EVERY INDIVIDUAL, whether rich or poor, is a Consumer from the moment of his birth till his death, because we are constantly in need of "Goods and Products" on the one hand & "services" on the other for our daily sustenance. It is therefore but proper that all of us should become aware of our rights as a consumer of goods and services.

In fact, it is well known that the ordinary consumer is often exploited to such an extent that the market slogan was "buyers beware". However, slowly but surely the scenario is changing, to enable the consumer to turn back and, now say "sellers beware".

While Consumer Awareness on the one hand and the need for consumer satisfaction on the other is a fairly well accepted and established fact in most western and other developed countries, this is taking its roots in developing countries and more particularly in our own country only in the last few years.

One significant reason for the spread of consumer awareness in our country has been the enactment of unique Legislation, the Consumer Protection Act in December 1986. The preamble to the Act states that it is intended to provide better protection of the interest of consumer and for the speedy settlement of disputes.

CHILD LABOUR ERADICATION PROGRAMME

The organisation conducted the programme in SAMASTIPUR District of Bihar State. The initiatives and support for the Eradication of Child Labour in India, through the government sector, mon-government sector, judiciary, social workers and public at large has raised hopes for creating mass movement against the menace of child labour and provide universal compulsory education for children. Several legislations have been passed from time to time to prohibit or improve the



working conditions of child labour. Legislation relating to the regulation of child labour concentrates mainly on four basic issues;

ADOLESCENT PROGRAMME

The organisation conducted the programme in SAMASTIPUR District of BIHAR State. The Adolescence Education Programme (AEP) is an important initiative that aims to empower young people with accurate, age appropriate and culturally relevant information, promote healthy attitudes and develop skills to enable them to respond to real life situations in positive and responsible ways. National Council of Educational Research and Training (NCERT) co-ordinates the program and works through both curricular and co-curricular formats to contribute toward holistic development of young people in pursuance of the National Curriculum Framework, 2005. National Popular Education Programme (NPEP) is being implemented in 30 States and Union Territories. It aims to develop awareness and positive attitude toward population and development issues leading to responsible behavior among students and teachers and, indirectly, among parents and the community at large. Imparting authentic knowledge to learners about Adolescent Reproductive and Sexual Health (ARSH) concerns, inculcating positive attitude and developing appropriate life skills for responsible behavior are also the objectives of NPEP.

RURAL WATER SAFETY & HEALTH SECURITY WORKSHOP

The organisation conducted the programme in SAMASTIPUR District of BIHAR State. The workshop conducted by Key resource persons from Water Aid India and will focus on providing an overview and brief an alysis of various Water, Sanitation and Hygiene policies and their delivery models in India, both for urban and rural settings. The sessions will also briefly cover the equity and inclusion needs, realities and ways forward for these policies and programs.

This workbook is designed to be used by participants attending a water safety plan (WSP) training workshop that has been organized around the materials developed by the International Water Association (IWA) and World Health Organization (WHO). The learning material included in this

workbook relates explicitly to the theory sessions that will be presented and the designed exercises. It therefore cannot be used as a standalone document to train people on all WSP aspects

CHILD PROTECTION WORKSHOP

The organisation conducted the programme in SAMASTIPUR District of BIHAR State. This two-day CIS Child Protection Foundation Workshop provides you with an overview of key topics relating to child protection and safeguarding within international school communities. It enables your school leaders and counsellors to both build new and strengthen existing child protection and safeguarding systems in your schools. You will explore the information and tools necessary to comply with international safeguarding standards and accreditation frameworks and will start thinking about how you can take action so that your school can better prevent, identify early and manage appropriately all forms of harm and abuse to which your students may be exposed.

- Ensure school communities possess knowledge and a shared understanding of the signs and risks of child abuse.
- identify problematic sexual behaviour, including peer-on-peer abuse and virtual abuse, and explore how to support and educate students to develop self-protective skills.
- Understand how to create and implement effective systems, policies and practices to identify, prevent and respond to harm and abuse within your school community.
- Address challenges facing international school communities as they strive to interpret various cultural attitudes, laws and actions in addressing forms of abuse.
- Develop knowledge of age-appropriate, healthy relationship education for children and young people based upon new UNESCO and WHO guidelines.
- Develop understanding and common interpretation of the international safeguarding standards and the CIS accreditation standards.

HERBAL GARDEN PROMOTIONAL PROGRAMME

The organisation conducted the programme in SAMASTIPUR District of BIHAR State. NMPB intend to establish herbal garden of various types to popularize the usefulness of commonly available and frequently used Medicinal Plants among the various stakeholders and sensitize the public about our traditional knowledge. It is also a way of conserving Rare, Endangered and Threatened (RET) species of Medicinal Plants. Herbal Gardens of various kinds will be promoted under the scheme to create awareness about traditional usage of medicinal plants. This would include Herbal Gardens of National and State importance as well as at the level of Institutions, Schools, Universities, Colleges and Homes.

Government Organizations, Universities, Research Institutes, Government Aided Colleges and Schools.

Non-government Organizations (NGOs), Public Sector Undertakings, Federations, Cooperatives, and Societies including Housing Societies etc Encouraging herbal gardens in the homes is a good way to promote use of medicinal plants for primary health care at the household level.

Setting up of herbal gardens in schools is a good way of reaching the minds of children and make them acquainted with the commonly available and frequently used medicinal plants.

Due to side effects of synthetic products, herbal products are gaining popularity in the world market. In spite of well-practised knowledge of herbal medicine and occurrence of a large number of medi-cinal plants, the share of India in the global market is not up to the mark. The present article deals with the measures to be adopted for global promotion of Indian herbal products. MEDICINAL herbs are moving from fringe to mainstream use with a greater number of people seeking remedies and health approaches free from side effects caused by synthetic chemicals. Recently, considerable attention has been paid to utilize eco-friendly and biofriendly plant-based products for the prevention and cure of different human diseases. Considering the adverse effects of synthetic drugs 1,2, the Western population is looking for natural remedies which are safe and effective. It is documented that 80% of the worlds population has faith in traditional medicine, parti-cularly plant drugs for their primary healthcare. India is sitting on a gold mine of well-recorded and tradi-tionally well-practised knowledge of herbal medicine.

Agriculture ext. & Training Programme

The organisation conducted the programme in SAMASTIPUR District of BIHAR State. It is important to disseminate information about new technologies so that the farmer is able to make use of the latest agricultural developments. There also exists a gap between research findings and the needs of farmers. For technology to be successful, it is important that it should serve a useful purpose to the end user. The institution that bridges the gap between farmers and agricultural research scientists is the Agricultural Extension Service. This service works through an Agricultural Research System in the States. The Sub Mission on Agricultural Extension (SMAE) focuses on awareness creation and enhanced use of appropriate technologies in agriculture & allied sectors. It has four main components, namely: The aforesaid components of Sub Mission on Agricultural Extension (SMAE) were run as separate schemes of Extension Division. These were recently subsumed under the umbrella of SMAE. Brief details about these are given in the subsequent paragraphs. As the name suggests, this scheme supports the state governments in their Extension Activities. It aims at making extension system farmer driven by way of new institutional arrangements for technology dissemination in the form of an Agricultural Technology Management Agency (ATMA) at district level to operationalise the extension reforms. Funds are released to State Governments in accordance with the scheme guideline which is also dependant on the State Governments releasing their share of contribution.

OTHER ACTIVITIES
